With reference to processing of pending applications for recognition of stand-alone programmes the Committee gave general instructions as recorded below. For purposes of self-contained clarification, these will be incorporated in the order in every individual case.

- (i) Applications for recognition of new units of recognized courses received before notification of the 2014 Regulations were kept frozen because of a Supreme Court directive that all the pending applications shall also be decided in accordance with the new Regulations.
- (ii) The present case falls in this category. If it were to be processed under the new (2014) Regulations, then, it would be hit by Regulations 3(a) and 8(1) which specifically prohibit applications for stand-alone units. This case was, therefore, held back from consideration in the SRC meeting on 07-09 Jan, 2014 subject to clarification to be received from NCTE (H.Q).
