Even if it was a new list with necessary rectifications, we could still not have accepted it as it was received long after midnight of 2.5.17. Accepting a new list in the morning on 3.5.17 would have amounted to violating the time-limit prescribed by the Supreme Court for issuance of FR w.e.f. 2017-18. That being so, we humbly state that there was no lethargy on our part in application of mind that would have resulted in any perversion of justice.</p> <p>(iv) In the given circumstances, and the prevailing instructions, it will not be within the power of this committee to reconsider this case for 2017-18 even if all the conditions are fulfilled.
